- Loan status must be Approved.
- Rate must be locked and locked Loan Estimate must be sent out one business day prior to CD
- Completed Appraisal Report on Jumbo and NON- QM Loans
- Evidence of hazard insurance and flood insurance (if impounded) OR quote from company if EOI not available
- 3rd Party Invoices
- Estimated Settlement Statement/Preliminary CD from Title
- Real Estate Agent Information
- Once CD is out, switching Comp Plan (from LPC to BPC) is not allowed
